Why Strategic Initiatives Struggle

Scope Drift

Projects drift beyond original intent without strong structure, controls, and ownership.

Resource Strain

Teams get pulled in too many directions, with limited visibility into who owns what and why.

Hidden Risk

Small issues stay hidden until they become crises. Risk is often underreported to avoid conflict.

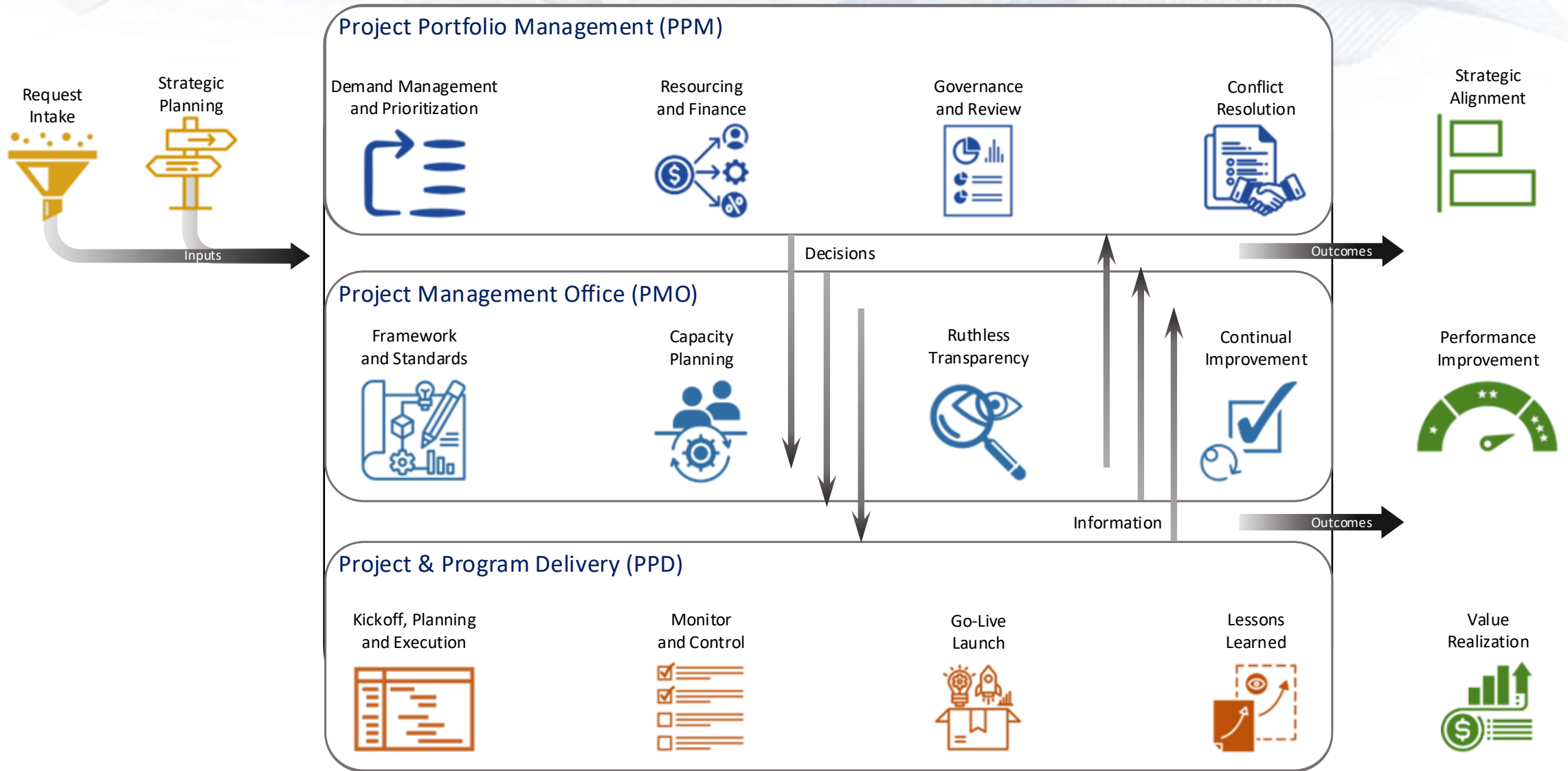
